The mission of Odyssey Charter School, working in partnership with the family and the community, is to help each child reach full potential in all areas of life. - E. MANAGEMENT COMPANY REPORT
 - 1. Update Constance Ortiz reported on the opening of the schools and the management company. She gave a brief history as herself moving from the original Director of Odyssey to expanding the school and moving over to Academica Central Florida (ACF) in order to open more green and healthy schools. The main goal was to focus on the mission of the school, but it was difficult to do so as we were also operating ACF schools. We left ACF to open Green Apple School Management to scale-up and open more green and healthy schools. Green Apple, which was ACF, has been operating at the same cost for the last 5 years. Thomas Cole mentioned that management companies operate at approximately 12% of the school's FTE with a 2% contingency, and Odyssey's fees are approximately 7%. Constance mentioned that in the future Green Apple will present a plan to the Board to raise Odyssey's management fee, but remain competitive with other management companies.

F. ADMINISTRATOR REPORT

- 1. Odyssey Charter School Working through PLC's, report cards went out, extracurricular activities are getting ready to begin. Wax museum next week for 4th grade.
- 2. Odyssey Preparatory Academy There has been an increase in diagnostic and benchmark results. This year's School Improvement Plan predicts that the number of suspensions will decrease. We are noticing a slight decrease. Reading intervention is focused on Phonemic Awareness, Phonics, Fluency, Vocabulary, and Comprehension. Math intervention started this week. We are using the Intervention Kit that is a component of our Envision Math curriculum. Math groups were made using Study Island data and teacher input. Students are responding well to the implementation of the Social Skills curriculum.
- 3. Oasis Preparatory Academy Oasis now has 153 students with a total of 10 teachers. Baseline data has been done with Study Island. Next week the students will be working on Study Island regularly. Marzano training begins next week. Soon the students will participate in characters on parade for book study month. Students will dress as their favorite book character and talk about why they chose that character.
